Audit report of balance sheet

Dr. Bhumesh Kumar, Treasurer, ISWS presented the ISWS Audit Report of the year 2016-17, which included the receipt and expenditure related to Biennial Conference held during 1-3 March, 2017 at MPUAT, Udaipur, Rajasthan. While presenting the expenditure incurred in ISWS Conference held at MPUAT, Rajasthan, EC observed that receipt presented in relation to expenditure to Biennial Conference by the local Organizers has not been properly accounted in the Society account. Seeing all the previous letters sent by the then Secretary, Dr. A.R. Sharma to Director Research and Vice Chancellor, MPUAT, Udaipur about this anomaly, it was decided by EC to pursue the matter with the Vice Chancellor of

MPUAT to settle the account and to get return the savings in ISWS account at the earliest. It was found that University did not pay the amount to various vendors from the fund received on the name of ISWS Biennial Conference. It was also observed that many irreverent vouchers of expenditure were claimed by the organizers from ISWS. Dr. Sushilkumar, Secretary was entrusted to prepare a draft to be addressed to the Vice Chancellor, MPUAT, Udaipur with a request to interfere in this matter and settle the account by the Local Organizing Committee at the earliest. The letter may be sent in the name of ISWS with the President signature. It was also resolved that if it became necessary, ISWS will approach higher authorities of the state.

Foreign Travel Grant

It was decided to sponsor maximum three life members up to Rs 30,000/- each year for participating in conference/Symposia/ workshop being held outside of the country. Following criteria were made:

1. Applicant should have minimum 10 years standing as life member.
2. It must be international event on weed science or related subject outside the country.
3. Paper must be on weed science subject only.
4. Application should be forwarded through the competent authority of the Institute / University.
5. Grant will be reimbursed on actual bill basis maximum up to Rs. 30,000/- after availing the travel
6. Acceptance should be minimum for oral/lead/Invited paper
7. Candidate should apply at least 4 months before the commencement of the event. The year will be counted January to December basis. In case, if already quota of three grants is exhausted for the concerned year, no consideration on application will be made for the event of that year.
8. Grant proforma will be evaluated by the EC members and marks obtained from each member will be averaged. Minimum 60% marks should be obtained to qualify foreign travel grant. In case, there is more application for a particular event in a year, top scorers will be selected on the merit basis.

Secretary was entrusted with the job of developing suitable proforma in consultation with EC members, which should be uploaded on the ISWS website.

Sponsorship for life members for foreign travel grants from industry and private agency

In the interest of ISWS members towards the knowledge enrichment in weed science, it was felt to mobilize funding support from Industry and other private agencies for the life members to attend the International Conference/Symposia/Workshops outside India in the field of weed science. It was decided to receive the funding by ISWS from any interested agency in favour of any individual life members of the Society for participating in conference/symposia/workshop to be held in abroad. In such case, concerned agency can transfer the money in ISWS account with recommendation to support any specific life members. ISWS will give such funding to that concerned individual from the society under the bye laws of the Society X at sl. No. 07.

To develop guidelines for best paper award published in IJWS from the grant given by Dr. B.S. Chauhan

It was proposed by EC to finalize the guidelines to honor suitably the authors of three best papers per annum published in IJWS from the interest accrued from the grant received from Dr. B.S. Chauhan. It was decided that Chief Editor will initially select best 15 full papers published in IJWS during two previous years excluding the year of Biennial conference after seeking the opinion of two independent experts. The papers will be finalized in consultation of EC for awards. The memento with citation, certificate and accrued award money will be given to first author or any coauthor in person only. In case no author comes, the award will not be given. No TA/DA will be provided to winning candidates.

To grant fund to councilors to organize activities under banner of ISWS

The President, Dr. V.P. Singh desired that each councilors do some activities under the banner of ISWS. For this purpose, councilor should move a proposal with the tentative plan to take the consent of EC. On approval, a matching grant of Rs. 10,000/- will be granted to the Councilors. It was also decided that each Councilor should pursue the authority/Librarian/Library Committee for the subscription of Indian Journal of Weed Science. The Councilors should also encourage students to purchase the book on weed management, published by ISWS and to become life members of ISWS.

Holding of ISWS Golden Jubilee Conference

In previous EC meeting, it was proposed to organize ISWS Golden Jubilee Conference on commemoration of 50 years of the Society in 2018, but it was decided to discuss the matter in next EC with the joining of more EC members. In this meeting, a detail discussion was held on dates, venue, circulars, brochures and forming of various committees. Directorate of Weed Research, Jabalpur was unanimously decided to be the venue of the conference. It was decided to organize Conference during 21-24 November, 2018 on the theme ‘Weeds and the Society: Challenges and Opportunities’.

Sub-themes:

- Weed biology, ecology including climate change, weed survey and surveillance and weed seed bank
- Weed management in rice based cropping system
- Sustainable weed management in cereals, pulses, oil seed crops, commercial crops, fiber and fodder crops
- Weed management in fruits, vegetable, medicinal, spices, floriculture crops besides landscaping horticulture
- Management of problematic weeds of crops and non-crops situations (*Cynodon*, *Cyperus*, *Lantana*, *Mikania*, *Chromolaena*, *Parthenium*, *Cuscuta*, *Orobanchae*, *Striga*, *Loranthus*, *Pistia*, *Salvinia*, water hyacinth alligator weed etc)
- Non-chemical weed management (cultural, mechanical, biological, soil solarization, mulching, stale seed bed, tillage conservation, organic farming, residue management, allelopathy and allelochemicals etc.)
- Herbicide resistance and herbicide tolerant crops and nano-herbicides
- Herbicide residues, monitoring, mitigation and effect on non-target organisms in weed management
- New herbicides molecules, new formulations, low dose herbicides, herbicides mixtures, herbicide compatibility with other agro input etc.
- Socio-economic implications; improving profitability of farming by new techniques, weed utilization, adoption, weeds on human and animal health


Publications: It was decided to bring out a first information brochure immediately so that it could be given to delegates attending 26th APWSS conference in Japan and to circulate among the members. Dr. Sushilkumar, Secretary was asked to develop such first-hand informative brochure and to circulate to EC members for further improvement. A complete conference brochure and sponsorship brochures should be ready by December 2017 for further circulation.

It was decided to bring out a publication on “50 years of weed research in India’ and a special issue of common general interest topics for Indian Farming. Dr. J.S. Mishra was requested to make a preliminary list of topics and to identify author(s) for the same for further discussion.

Accommodation and conveniences: Efforts will be made by the local organizers to provide suitable accommodations to Indian delegates in different guest houses and hotels. Foreign delegates will be accommodated only in hotels.

It was decided to provide no pickup and drop convenience from airport and railway station, however daily pickup and drop facilities will be provided from staying place to venue. A suitable travelling agency will be facilitated for local and outside excursion tours on hiring basis.
